

**2.6.1 Programme Outcomes (POs) and Course Outcomes (COs) for all Programmes offered by the institution are stated and displayed on website and attainment of POs and COs are evaluated in different ways.**

**Response:**

In Vivekananda Mahavidyalaya, Burdwan, the curriculum of all the programmes is framed by the University of Burdwan based on CBCS and NEP. However, Vivekananda Mahavidyalaya, Burdwan offers varied programmes and courses with an aim to provide high quality education to meet the current national and global requirement in academics, professional and career management. Some of our teachers who are members of the Board of Studies of the University of Burdwan, put their suggestions into the curriculum and syllabus from time to time.

Under the direction of Internal Quality Assurance Cell (IQAC), with the commencement of each session, the In-charges of various departments together with their faculty members prepare the learning outcomes based on the syllabus. Any change in the syllabus incorporated by the University is given due importance to modify the respective learning outcome of that particular course. Every department of our college has clearly stated Learning Outcomes of the syllabus which is duly endorsed by the IQAC of the college.

**Programme Outcome (PO):** Programme Outcomes are statements about knowledge, abilities, and attitudes (attributes) that students ought to possess after a formal programme (for example, a three-yea degree course in Arts/Science). POs deal with the general aspect of a graduation programme as well as the skills and knowledge a graduate will have after completing the programme. POs are more general statements that outline what students should study and be able to do after receiving their bachelor's degree. They also indicate the skills and knowledge a graduate should have after completion of a programme. PO for a programme has been adopted by the National Board for Accreditation (NBA), primarily based on initial capabilities, competence, skill, etc. and is unique for a particular programme,

**Programme Specific Outcomes (PSOs):** These are statements that describe the outcome of specific subject-based programmes included in POs. They help students to understand how the skills they acquire in a particular programme would directly contribute to the advancement of the society and its sustainability.

**Course Outcomes (COs):** They are precise, quantifiable declarations of the information, abilities, and attitudes that students will have acquired by the end of a course as included in PSOs. Course-specific learning outcomes indicate a demonstrated activity that is ideally observable, measurable, and attainable within a predetermined time frame.
